Rules and Regulations

General information Metcalfe Idol will be held during Summerfest on the Metcalfe County Courthouse Square on Saturday, June 7th, 2025.

Eligibility You must be a resident of Metcalfe County, Kentucky. This contest is open to amateurs only, meaning you are ineligible if you already have either talent representation or a recording contract. Metcalfe Idol is open to contestants of all ages. There will be two age divisions: Youth for ages under 16 and Adult for anyone age 16 and over. We are limited to 10 contestants per category. All participants under the age of 18 MUST have an adult present during the event.

The Process Registration will take place on the day of the event from **8 30 am to 10 30 am** at the Edmonton-Metcalfe Chamber of Commerce booth. The youth competition will begin at 11 am and the adult competition will begin at 12 Noon. Contestants will perform one song of no longer than 3 minutes. All performances must be accompanied by music (either live or prerecorded). The event will be judged, and the judges' decisions are FINAL. Contestants will be scored on the following: stage presence, song presentation, vocal ability and performance attire.

Prizing The Top 3 in each category will receive a medal. The Top Winner in each category will receive \$25.00 in Metcalfe Money in addition to the medal. All prizes will be awarded on the day of the contest.

Disqualification We reserve the right to disqualify or exclude, in our sole and absolute discretion, any individual for any reason. We also reserve the right to change the rules and procedures at any time. Inappropriate attire or song lyrics will result in disqualification.

General conditions by participating, entrants agree to be bound by these rules and the decisions of the judges, which shall be final and binding. We reserve the right to use the names and likeness of entrants as part of that publicity, without compensation. In the event of inclement weather, the contest will be subject to cancellation or rescheduling.

Waiver We, the Participant and/or Guardian, Release and forever discharge and hold harmless Metcalfe Idol and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the activities as a participant in Metcalfe Idol, including claims arising out of negligence.
